### **LIABILITY**

The use of an invalid card resulting in a late payment will result in a late fee equal to 10% of the total past due amount (per month). If my account balance becomes delinquent, my playing privileges and charging privileges shall be suspended until my account balance is brought back to current. In the event my account becomes over 60 days past due, the Club reserves the right to terminate my membership and pursue collection of the unpaid balance through customary collection channels. I hereby agree to reimburse the club in full for all legal fees and collection agency charges associated with the collection of my account.

Country Club of Arkansas is a non-equity, semi-private club owned by HJY Golf, LLC. Membership privileges to the Club are subject to the Rules and Regulations established by the Owner.

### **INITIATION FEES**

I agree to pay a joining fee of \$1,000. My joining fee will be waived in exchange for the signing of a one year membership contract. If I waive the joining fee I hereby agree to be responsible for the full year membership.

### **AUTO RENEWAL**

My membership automatically renews every year on my anniversary date unless cancelled by me, in writing, at least 30 days prior to the date of auto renewal.

### **RULES AND REGULATIONS**

I agree to comply with all the Rules and Regulations of the Club. Specific to this cart-included membership, I understand that the individuals enrolled in this membership may use club-owned carts FREE of charge. Club owned carts shall be shared whenever possible, and within a particular group, members shall utilize the minimum number of fleet-carts required in order to accommodate the members or paid guest in that group. A cart fee of \$25 shall be charged to the account of any member riding solo in a cart while there is an empty seat in another fleet-cart in the same group. All members are required to check in and obtain cart-authorization prior to the beginning of each round, including replays. In the case of golf cart shortages, the club reserves the right to distribute carts in whatever order deems appropriate.

### **DRIVING RANGE**

My use of the driving range is complimentary throughout the term of this contract. Management reserves the right to restrict such complimentary range access in future years, or may charge an optional fee for continued unlimited access. I agree to leave all range equipment, including balls, on the range.

### **PRIVATE CART USAGE**

Full Members who reside within The Country Club of Arkansas subdivision may operate their own approved, personally owned golf cart. All carts shall be subject to an inspection by the course personnel prior to being placed into service. Gasoline models may not be used. There is a \$25 per month Trail Fee, which will be billed along with dues charges (whether paid monthly or annually)
